# HOW TO BENEFIT FROM WORKING WITH A FREELANCE ATTORNEY

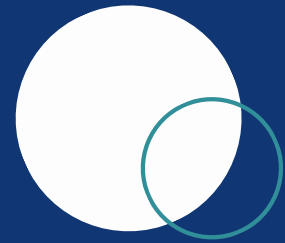

- Work/life balance

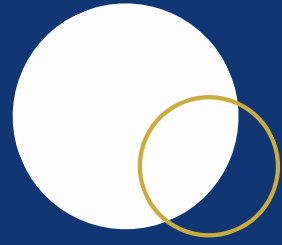


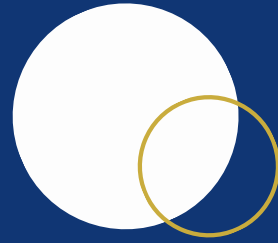
